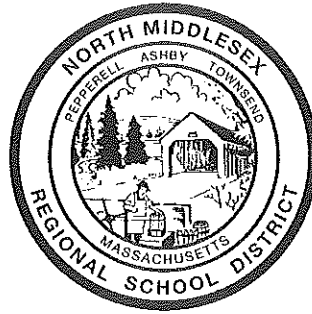

Dear Ms. Dunnet:

Please be advised that on April 29, 2024, the North Middlesex Regional School District Committee voted to re-adopt the school district's 2024-2025 total budget. The adopted budget is \$67,087,143 with an operating budget of \$58,475,817, transportation budget of \$4,467,164, and debt service of \$4,141,162. In accordance with the provisions of Section 16B of Chapter 71 of the General Laws of Massachusetts, I, as Treasurer of the North Middlesex Regional School District, hereby certify, Townsend's apportioned amounts of money necessary to be raised by Townsend to maintain and operate the District schools during the fiscal year 2024-2025. The amounts required for payment of the debt and interest incurred by the District which will be due in said year is as follows:

Operating Assessment	\$ 12,411,707.00
Transportation Assessment	1,244,706.00
Debt Assessment	<u>1,335,286.00</u>
TOTAL	\$ 14,991,699.00

The operating and debt assessment amount is to be paid to the District Treasurer in four installments not later than August 1, November 15, February 15, and May 15.

Townsend's share of the \$4,141,162 debt service amounts to \$1,335,286.00. Because the debt must be paid by the district on the due date, the district will add a charge of .0329% per day for every day (12% per annum divided by 365 days) that it is late to the balance of any unpaid installment outstanding at the usual close of business beginning with the first day after such payment or portion thereof is late.

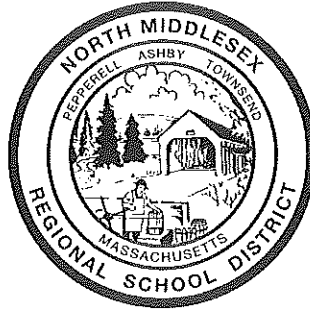
